

## CUSTOMER MEDIA CONSENT AND RELEASE

I, from ("Customer"), confirm that I am authorized to act for and on behalf of Customer and am willing to act as a reference for Bender Electronics, Inc. and its affiliates ("Bender").

I, for and on behalf of Customer, hereby give Bender permission to use Customer's name and other identifying information as part of the Bender sales and marketing activities and related reference materials that Customer and Bender mutually approve.

I irrevocably waive any claim against Bender and any of its affiliates within the Bender Group relating to the use of my Reference and the Approved Content and promise not to bring any such claim or action in the future. I also understand that the Approved Content will become the property of Bender.

**Representations**.
